

Eastern City Tree Photo Competition 2024 Terms & Conditions.

Selfie Challenge: Snap a selfie with the tree, then tag and follow @ecbidlondon and @panpacificlondon for a chance to win.

1. Promoter:

The promoter of this competition is the Eastern City Business Improvement District, located at Dashwood House, 69 Old Broad Street, City of London, EC2M 1QS

2. How to Enter:

To enter the competition, participants must:

- Take a picture with the tree located at One Bishopsgate Plaza
- Share the photo to Instagram and tag both @ecbidlondon and @panpacificlondon in the photo.
- Follow both @ecbidlondon and @panpacificlondon on Instagram.

The selfie must be posted on Instagram feed to be eligible for entry. Only one entry per person is allowed.

3. Eligibility:

- The competition is open to UK residents aged 18 or over.
- Employees, agents, or representatives of the promoter or any of its associated companies are not eligible to enter.
- The competition is not open to residents of Northern Ireland.

4. Competition Period:

The competition opens on 14th November 1800hrs and closes at 4th January on 1800hrs. Any entries received after this time will not be considered.
